<u>O R D E R:</u>

In the G.O.1st read above, Government have issued orders directing all the Dist Collectors to provide house site of 50/100 Sq.yds within the same dist preferably in the head quarters town, to war widows and disabled ex-servicemen of the state, on free of cost.

Further the Government in its G.O.2nd read above, issued orders for allotment of house site upto 300 sq.yds at the native place to the defence personnel killed in action or disabled in action in OP-VIJAY. In case the native place being a urban area, in addition to house site allotment facility already available under the existing rules, out of turn allotment of one residential flat/house in an A.P.Housing Board project would be made available on cost basis at rate applicable to such residential flat/house.

The Director, Sainik Welfare / Chairman, Sainik Welfare Committee, Hyd., in the reference 4th and 5th read above has requested the Government to kindly extend the benefit of allotment of house site pf 300 sq.yds in rural and urban areas to the dependents of personnel killed in action / disabled in action on par with benefit provided under OP-VIJAY, as a welfare measure for the services rendered by them for the country and also reported that at present there are nearly 167 cases of war widows and war disabled who have not been allotted house / house sites are pending in various Districts.

The Government after careful examination of the matter, hereby decided to extend the benefits for allotment of house site of 300 Sq.yds in rural and urban areas to the dependents of personnel killed in action / disabled in action with enemy forces.

The Dist. Collectors in the state are directed to provide the house sites to the dependents of personnel killed in action / disabled in action with enemy forces as ordered above.
